2. **Requisites:**

Prerequisite(s): Geology 337 and 381; one of Geology 311 or 333; one of Geology 341 or 343 and admission to the Geology or Applied and Environmental Geology programs and consent of the Department.

Antirequisite(s): Credit for Geology 435 and either Geology 437 or 439 will not be allowed.

Notes: A maximum of 6 units may be taken. This course occurs in rugged field conditions and varying weather, for which participants must be prepared and equipped. It may occur outside Canada. A supplementary fee will be assessed to cover additional costs associated with this course. Students will require consent of the department to drop this course. MAY BE REPEATED FOR CREDIT

3. **Grading:**

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

Course Outcomes

- Navigate in the field using a topographic basemap and locate positions with accuracy and precision.
- Maintain high quality field notes with good sketches and a clear system that connects the notes in the field book to the geologic map.
- Operate basic geological field instruments and tools: strong familiarity with strike, dip, trend, and plunge including the various methods for obtaining these parameters with an analogue geologic compass. Proper use of hammer, handlens.
- Develop the ability to distinguish between various geologic contacts (e.g. faults, unconformities, depositional contacts, intrusive contacts etc.) and transfer these observation onto a geologic map along with measurement data, sample locations, and outcrop data stations.
- Construct working hypotheses to unravel structural problems and explain geologic observations, and develop logical tests for hypotheses in the field. Record these hypotheses and the tests in field notes.
- Contribute effectively to a geological mapping team both to perform field surveys and to complete team deliverables reporting on the results.
- Produce high quality field notes, maps, measured sections and cross sections.
