Note that this text is over 15 years old, and the theory is still up-to-date, but the references to global geophysical models for the gravitational and magnetic fields may be out-of-date. The instructor will also post supplemental notes or links to other resources on D2L (https://d2l.ucalgary.ca/login.asp).
