Course Description

COMS 501 is an individual directed study offered to students enrolled in the Food Culture in Spain 2014 Group Study Program. Students chose a topic of their choice and with the guidance and direction of one of the two accompanying instructors, conduct secondary and primary research to answer a research question on that topic.

Additional Information

This course is part of the Food Culture in Spain Group Study Program and is not offered on campus

Objectives of the Course

To give students an opportunity, under the supervision of one of the instructors, to explore in depth a food related topic of their choice through both experiential primary and scholarly secondary research.

For the essay, students will be required to submit a proposal and preliminary annotated bibliography for feedback and approval before departure. This major paper will be 4500-5000 words in length. Essays will be due three weeks after the end of the program.

Assignment Descriptions

Preliminary Proposal

Students will submit a preliminary proposal of 350-450 words outlining their topic, research question, social/historical context, theoretical framework and research methods that will be undertaken in the field. Course based ethics approval will be obtained to allow students to undertake primary research in the field and the program assistant will be available to help students with translation if required.

Annotated Bibliography

Students will submit a properly formatted APA-style annotated bibliography of 8-10 scholarly sources on their topic. Each annotation should be approximately 3-5 sentences, and should provide a brief description of the book/article's main argument and the relevance of this source to the student's research.

In Field Progress Report

While in the field, students will be required to submit a two-page update on the research progress to date. This report should include a summary of data gathered, interviews scheduled, any shifts in research question, and challenges encountered to date. Deadlines for reports will be assigned in advance of departure based on the timing of students' data collection in the field.

Final Essay

Three weeks after the program's completion, students will submit a formal research essay of 4500-5000 words, worth 50% of their course grade for COMS 501. This essay will combine their primary research in the field with the scholarly sources collected pre-departure. Detailed essay guidelines will be provided to students outlining the theoretical and methodological expectations for the essay, and students will have regular meetings with their supervising instructor regarding the progress of their research. Final essays will be evaluated on the quality of primary and secondary research, strength of analysis, and clarity of writing.

All assignments must be completed or a grade of F may be assigned at the discretion of the instructor.

It is the student's responsibility to keep a copy of each submitted assignment.

A night drop box is also available for after-hours submission. Assignments will be removed the following morning, stamped with the previous day's date, and placed in the instructor's
