Dr. Vivian Mozol is course/tutorial coordinator. Dr. Yuen-Ying Carpenter is the laboratory coordinator.

The Tutorial activities and Lab Experiments will alternate on a weekly basis, except for the week of Term Break (February 19th-23rd). Please see the calendar in the course syllabus posted in D2L for the weekly schedule & your Student Centre for the exact location and time of your lab or tutorial session.

To account for any necessary transition to remote learning for the current semester, courses with in-person lectures, labs, or tutorials may be shifted to remote delivery for a certain period of time. In addition, adjustments may be made to the modality and format of assessments and deadlines, as well as to other course components and/or requirements, so that all coursework tasks are in line with the necessary and evolving health precautions for all involved (students and staff).

## In Person Delivery Details:

The learning outcomes for the course will be delivered in-person. The learning objectives, and a class calendar outlining which learning objectives are covered each week, can be found within the Syllabus for the course posted on the D2L website. Students will be assessed on their understandings of the course content via the following course components:

**Lecture.** In-person Lectures begin on Monday January 8th, 2024. Lectures will occur weekly on Monday Wednesday, and Friday at 2:00 - 2:50 p.m. for L01 and on Tuesday and Thursday at 8:00 - 9:45 a.m. for L02. When appropriate, students will work in unstructured groups. Both sections will formatively check understanding periodically through in-class discussions and polling.

Though there are different lecturers listed for each section, both lecture sections will cover the same material and be assessed using the same exams (Midterm and Final). Each section will have their own D2L webpage on which instructors will post materials relevant to classes specific to the section they teach as needed.

**Tutorials.** In-person Tutorials begin on January 16th, 2024. Students will conduct five bi-weekly tutorial activities, as scheduled in your Student Centre. Tutorials will be worth 20% of the course grade. For details on the grading of tutorial activities, see Section 3.

**Labs.** Lab Activities begin on January 8th, 2024. There are six bi-weekly activities. Week 1 (Lab 0) is online and self-paced; **all remaining lab weeks (Labs 1-5) are in-person experiments**, as scheduled in your Student Centre. Experiments will be worth 25% of the course grade. For details on the grading of lab experiments, see Section 3.

### Antirequisite(s):

Credit for Chemistry 201 and any of 209, 211, 301 or Engineering 204 will not be allowed.

## 3. Grading:

As noted in Section 1, labs alternate biweekly, including 1 online lab week and 5 in-person lab weeks. Each lab may be graded on a combination of different activities due (i) before, (ii) during, and (iii) after the lab period. Details will be available on D2L.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

This course will have a Registrar Scheduled Final exam that will be delivered on-line. The Final Examination Schedule will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within hours.

In order to achieve the prerequisite requirements (i.e. C-) for future Science courses, a student must meet **ALL** of the following requirements:

Completion of a meaningful portion of the course activities, by...

- 1. Completing at least of 3 of the 5 tutorial activities, and,
- 2. Attending and submitting at least of 3 of the 5 in-person laboratory activities

AND meaningful assessment of mastery of the material, by earning...

- 3. An average score of at least 50% on the tutorials, and,
- 4. A weighted average score of at least 50% on the laboratories, and,
- 5. A weighted average score of at least 50% on the midterm and final exams.

Therefore, if ANY of the above five criteria are not met a maximum grade of D+ will result.

# 4. Missed Components Of Term Work:

In the event that a student legitimately fails to submit any online or in-person assessment on time (e.g. due to illness, domestic affliction, etc...), please contact the course coordinator, or the course instructor if this course does not have a coordinator to arrange for a re-adjustment of a submission date, or possible exemption and reweighing of components. Absences not reported within 48 hours will not be accommodated. Students may be asked to provide supporting documentation (Section M.1) for an excused absence, See FAQ.

If an excused absence is approved, options for how the missed assessment is dealt with is at the discretion of the coordinator or course instructor. Some options such as an exemption and pro-rating among the components of the course may not be a viable option based on the design of this course.

There will be no deferred midterm. If a student is unable to attend the midterm then the 20% of the course grade assigned to the midterm exam will be pro-rated to the final exam.

If you will miss a laboratory session, fill out the absence form (on D2L) as early as possible (minimum 14 days in advance for a scheduled absence; within 48 hours of the missed lab for an emergency or illness). While our ability to provide make-up labs is limited by staffing and room capacity, we strongly encourage you to apply for a makeup lab when possible to benefit from these hands-on experiences. While priority seating in the makeup lab is offered to students facing circumstances outside of their control, if spaces are available, other students may be placed in the makeup when possible.

Absence from at most two of the lab activities and at most two of the tutorial activities in this course could be excused in extenuating circumstances. The weight for any excused absence in labs or tutorials will be prorated towards other submitted work within that course component.

• If ongoing extenuating circumstances may prevent a student from meeting the minimum attendance requirement in either labs or tutorials, it is recommended that they meet with the course and/or lab coordinator as soon as possible to discuss what options may be in the best interest of the student's long-term learning.

- 13. In addition to the Lecture component of the course, students are scheduled for a Tutorial and a Lab Component. You must attend your assigned tutorial and laboratory time slots unless you have been given written permission by the course and/or laboratory coordinator to do otherwise.
  - Tutorial: Tutorial activities will begin the week of January 15th, 2024. The exact room location and time can be found via your Student Centre. There are five activities each worth 4% of your final grade. Attendance for two of the five activities could be excused in extenuating circumstances (see section 4. of this course outline regarding Missed Work). The overall average grade obtained for the Tutorial component of the course must be 50% to be eligible for a pre-requisite pass for the

course (see Section 3). Details for each activity are posted in D2L the week prior to the activity.

- Lab: Biweekly activities include 1 online, self-paced lab (Lab 0, week of January 8) and five in-person, scheduled labs (Labs 1-5). In-person labs begin the week of January 22 at the time and room specified in your Student Center. Additional details on the activities for each laboratory week activity are posted in D2L.
  - Laboratory Exemptions. Students who have previously completed the laboratory component in Winter 2022 or later may choose to be exempted from repeating the lab component of the course, if they obtained a overall lab grade of 75% or higher was obtained. Students opting to exempt from the lab should be aware that...
    - they must still complete the tutorial component of the course;
    - the material covered in the lab will be integrated into other course assessments such as the Midterm and Final exams; and.
    - the overall lab grade achieved on the previous attempt will be carried forward (for 25% of the overall course grade.
  - It is strongly recommended, therefore, that students do not apply for exemption and instead complete all lab activities, to best support their overall understanding of the course material.
    - Prior to applying for an exemption, students are encouraged to connect with the course coordinator to better understand the risks and benefits of an exemption, as well as what access they will (or will not) have to lab materials or feedback as an exempt student.
  - Students applying for a lab exemption should apply online through the Undergraduate Science Center (https://science.ucalgary.ca/usc-lab-exemption-application) no later than Monday January, 15th 2024. Students registering in the course after this date should contact the USC as soon as possible if they wish to apply for an exemption.
- 14. **Laboratory Safety Course.** All undergraduate students taking chemistry laboratories are required to complete an introductory course (approx. 50 minutes) on laboratory safety.
  - In CHEM 201, time has been set aside for you to complete the Safety Course as part of your first week of labs ( Lab 0, Week of January 8, 2024). This course is presented in a self-paced, online format and information on how to access it can be found on the course D2L site.
  - Students who have previously completed the Chemistry Undergraduate Safety Course at the University of Calgary in the
    past five years are NOT required to repeat it.

The Safety Course must be completed before your first in-person laboratory experiment (Lab 1). You will not be permitted to enter any laboratory space until you have successfully completed the safety course.

While the Safety Course will not count directly towards the final grade, the material is considered to be part of the course and is therefore appropriate for inclusion into laboratory assessments and course exams.

#### **Course Outcomes:**

- OBSERVATION/ANALYSIS: Collect and analyze observations related to experiential chemical activities.
- ATOMS; Use the quantum theory description of the energy and spatial distribution of electrons to correlate the physical properties of atoms with how atoms interact
- CHEMICAL SPECIES; Generate Lewis & VSEPR diagrams and use bonding theories to describe and evaluate the connectivity between atoms and spatial arrangement of bonding in a chemical species
- COLLECTIONS OF CHEMICAL SPECIES; Identify the charge distribution in a chemical species and use it to illustrate how
  collections of chemical species will interact with each other physically and chemically.
