3. Grading: The University policy on grading and related matters is described sections F.1 and F.2 of the online University Calendar. In determining the overall grade in the course the following weights will be used:

Laboratory experiments 25% e-learning (clickers) 5%

Midterm tests 25% (Oct. 10: 10% and Nov. 12: 15%) Final Examination 45% (To be scheduled by the Registrar)

The marks for each of the course components will be recorded as a numerical score and combined as shown above to arrive at the total numerical score which will then be converted to a letter grade to be reported to the Registrar. A mark of less than 50% in the laboratory component and/or on the weighted average of the term tests and final examination will result in a final grade of no greater than D+, which does not satisfy the pre-requisite requirements for further chemistry courses. Students will be expected to understand at every stage the material covered in all components of the course.

Any equipment that is missing, unusable or has been replaced during the semester will be charged to the student. All students, even those who withdraw early from the course must check out of the laboratory before the last day of lectures. Any student who fails to check out before the last day of lectures for the term will be assessed a charge of \$30.00. If this fee is not paid by the last day of the final examination period of the term, an additional \$10.00 administrative fee will be charged and university services (registration, transcripts, etc.) may be withheld.
