The student shall discuss the work with the Instructor within 15 days of either being notified about the mark, or of the item's return to the class. If not satisfied, the student shall immediately submit the Reappraisal of Term work Grade form to the Associate Head of Chemistry, Dr. Farideh Jalilehvand (ahugchem@ucalgary.ca), who will arrange for a reassessment of the work if, and only if, the student's argument is valid. Note: Students should attempt to present their rational as effectively and as fully as possible. Mere dissatisfaction with a decision is not sufficient grounds for the appeal of a grade, or other academic decision. See sections 1.1 and 1.2 of the University Calendar.
 - **(b) Final Exam:** A student wishing a reappraisal of the final grade should first attempt to review the final assessment with the department offering the course. If not satisfied, the student shall submit the request to the Enrolment Services. See <u>Section I.3</u> of the University Calendar.
