## **Online Delivery Details:**

Some aspects of this course are being offered in real-time via scheduled meeting times. For those aspects you are required to be online at the same time.

To help ensure Zoom sessions are private, do not share the Zoom link or password with others, or on any social media platforms. Zoom links and passwords are only intended for students registered in the course. Zoom recordings and materials presented in Zoom, including any teaching materials, must not be shared, distributed or published without the instructor's permission.

### 3. Grading:

Midterms 1 and 2 will available over a 24 hour period (asynchronous and timed). These will be designed for 50 minutes and will have a 75 minute completion time. The final exam will be cumulative, designed for 120 minutes and will have a 180 minute completion time.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

This course will have a final exam that will be scheduled by the Registrar. The Final Examination Schedule will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 2 hours.

The final exam will be administered using an on-line platform. Per section of the online Academic Calendar, timed final exams administered using an on-line platform, such as D2L, will be available on the platform. Due to the scheduling of the final exams, the additional time will be added to **the end** of the registrar scheduled **synchronous** exam to support students. This way, your exam schedule accurately reflects the **start time** of the exam for any **synchronous** exams. E.g. If a **synchronous** exam is designed for 2 hours and the final exam is scheduled from 9-11am in your student centre, the additional time will be added to the **end** time of the **synchronous** exam. This means that if the exam has a 1 hour buffer time, a synchronous exam would start at 9 am and finish at 12pm. – **updated April 6, 2021**

## **Course Outcomes:**

- Recognize important colloidal systems within applied chemistry and engineering.
- Understand the importance of interfaces and how they influence chemical changes / processes.
- Qualitatively describe the solid / gas interface, surface characterization and the influence of adsorption on chemical kinetics or selective separation.
- Describe how size, gravitational, centrifugal, thermal and viscous forces influence settling in a bulk fluid phase.
- Demonstrate how particle-particle interactions and the kinetic stability of colloidal systems are influenced by dispersive attraction and electrostatic forces.
- Qualitatively and quantitatively describe how salt solubility can be used to alter the rate of flocculation or coalescence in a colloidal system.
- Recognize and understand the importance of flocculation rates, steric effects, wetting / spreading descriptors, surface active solutes, emulsion stability and foam stability.
