COURSE CALENDAR STATEMENT: Introduction to Eastern religions – Hinduism, Buddhism, Jainism and Sikhism

COURSE DESCRIPTION:

This course on Asian Religions (RELS 203) provides a brief overview of religious traditions from South and East Asia. The course covers broad topics on Hinduism, Buddhism, Jainism and Sikhism; with a short module to introduce Shinto and Daoist (Tao) traditions in Japan and China respectively [time-permitting]. The course is geared towards presenting the core philosophies of Asian religions and their worldview adapted in the modern world.

RELS 203 adopts theoretical discussion and student-centered discussion through examples in class. Student should expect moderate to high engagement and reading tasks for this course. Students will engage in interactive class discussions, and critical reading in peer-groups.

Along with an introduction to Asian Religions, the course focuses on introducing research in the broader field of Religious Studies, to foster critical thinking skills, and writing practice.

*ASSESSMENT COMPONENTS

Group discussion/Class Participation (Ongoing) (40%): Students will participate in the class discussion in a group of 5-6 students. There will be 10 classes with graded participation component, as will be declared at the beginning of the course and timetable of activities will be posted on D2L. The activities include but are not limited to: critical analysis of selection from a primary text, analysis of a news article, and a discussion on video/movie presented in class.

Out of 10 instances of group/class participation modules, best 8 will be calculated for the final grade (5% each x 8 = 40% of the final grade)

Aligned course outcomes: 1,2,3,4

Written tests (Hinduism and Buddhism) (20% each): Written exams with multiple choice questions and short answers based on each tradition. These exams will be held in class, during the class time.

Written test (Jainism and Sikhism) (15%): Written text on the last day of the class, follows the same format as above.

Aligned course outcomes: 1,2

Short reflection essay (5%): Short essay on pre-discussed topic due on November 14th, 2022 after the reading break.

Aligned course outcomes: 1,2,3
