Selected topics on critical discourses in the study of religion.

COURSE DESCRIPTION:

This is an upper-level survey theories of narrative and their employment in the discipline of Religious Studies. As our case study, we will focus on the classical narrative literature of the Hindu tradition as preserved in Sanskrit (we will read these texts in English translation). Focusing on the genres of *katha* (fable), *itihasa* (epic), and *purana* (myth), we will examine the ways in which narrative conveys religious and moral value. The interpretation of narrative through the lenses of both classical Indian and contemporary western literary theories will be a central concern of the class. By the end of this course, students will develop a familiarity with the literary corpus of classical Hindu narrative and a detailed understanding of a few seminal narrative texts. In addition, students will be well-versed in the critical questions and issues pertaining to the role of narrative literature in religious culture. At the graduate level, we will also consider a variety of narrative theories and how they may relate to our course subject and to each students' research interests.

*COURSE LEARNING OUTCOMES

Students will have a strong familiarity with classical texts of the Hindu narrative genres, particularly those texts associated with the god Krishna. They will also have an advanced understanding of some theoretical frames used to interpret these texts in religious studies.

CLASS SCHEDULE

*EXAMINATIONS

*ASSESSMENT COMPONENTS

- 1. **Participation** (30%): Regular class attendance and thorough, thoughtful reading of assigned texts are essential to a successful seminar. Participation grades will be determined by the quality of each student's daily preparedness and contributions to regular class discussions.
- 2. **Presentations** (15% x 2): Each student will sign up for two classes to give oral presentations on the week's readings and lead discussion. Students may work individually or with a partner on their presentations. Guidelines on expectations for presentations will be distributed in class.
- 3. **Final Paper** (40%): Students will submit a research paper of 20-25 pages on a topic of their choice (related to the course content, of course). Further details on the requirements for the final paper will be distributed and discussed in class. The research paper is a project in which students will engage throughout the semester. To this end, students will be asked to submit a term-paper research proposal on Monday, February 27 *and* to schedule an appointment to discuss their research proposal with the instructor during the week of February 27-March 3. Failure to submit the research proposal or schedule an appointment with the instructor will result in a 15-point reduction in the student's final paper grade. The final paper is due April 18 by 11:59 PM and should be submitted to the D2L drop box.
