Each of the above components will be given a letter grade using the official university grading system (see <u>section F.1.1</u>). - Describe and summarize the roles of programming and computing in a broader context of topics that may include scientific and non-scientific computing, data storage and analysis, established sub-disciplines of computer science, history of computing, or social and philosophical issues.
