Objects of Literature

Course description: How do we define the object of literary studies? What counts as literature? How do we approach literary texts and why? How do we write about literary texts? This course will introduce students to literary studies as an academic discipline by examining numerous texts that explore relationships between persons and things, and between literature and material culture. In addition to examining texts that are explicitly concerned with material objects, we will also examine books as material objects to consider how the material instantiaion of a text affects our reading and understanding of it. This course prepares students for advanced undergraduate studies in English.

Course objectives:

- To develop an understanding of a range of technical terms and critical tools with which to interpret texts
- To develop critical reading and writing skills
- To develop information literacy, library research skills, and appropriate documentation methods
- To learn to engage meaningfully and appropriately with the works of other students and scholars through group discussion and critical writing

Assignments and Evaluation:

10% Attendance and Participation

15% Close Reading Exercise (500 words)

20% Short Essay (750-1000 words)

15% Critical Summary of a Secondary Source (250 words)

30% Final Essay (1500 words)

10% Final Exam

Attendance and Participation

Because in-class discussions, writing exercises, and peer-review sessions are integral to this course, regular attendance and participation are required. Students are expected to come to lectures having done all required readings and to be prepared to participate actively in class discussion and in-class exercises. Students missing more than 3 classes will lose 1% for every additional class they miss (unless appropriate documentation justifying the absence is provided promptly upon their return).

Close Reading Exercise

Students will prepare a 500-word essay focusing on the careful interpretation of a particular passage from one of the works under study. This close reading should provide a detailed interpretation of the passage in itself and in relation to the larger work in which it appears. For this assignment students will be asked to develop their own interpretations without the use of secondary sources.

Short Essay

Students will prepare a 1000-word argumentative essay focusing on one work under study. Essay topics will be provided. No secondary sources required. Students will have the opportunity to workshop a draft of their essay with peers in class.

Critical Summary of a Secondary Source

Students will provide a brief (250 words) critical summary of an assigned scholarly article, detailing: 1) the author's main argument; 2) the ways in which the author develops/supports his/her argument; and 3) the student's assessment of the implications of the author's argument.

Final Essay

Students will prepare a 1500-word argumentative essay focusing on one or more works under study. In consultation with the instructor, students will develop their own essay topic. Students must engage critically with at least one secondary source in this essay.

Final Exam

There is a Registrar-scheduled final exam for this course. The final exam will test students' close reading skills and their newly acquired knowledge of key critical terms and practices.

Additional Regulations:

- → Students must be available for examinations up to the last day of the examination period (Dec 12-22).
- → There are no extra-credit assignments in this course.
- → Students must complete all assignments in order to receive a passing grade for this course.
- → All assignments must adhere to MLA style guidelines (most recent edition).
- → All assignments must be submitted at the beginning of class on the day that they are due. Assignments submitted after the deadline will be penalized with the loss of 5% for each day [including weekends] that the

assignment is overdue. No assignments will be accepted one week past the assignment deadline without the prior consent of the instructor.

Please make every effort to take assignments directly to the instructor. If it is not possible to do so, take your assignment to SS 1152 and put it in the dropbox. Your assignment will be date-stamped and placed in the instructor's mailbox. It is your responsibility to keep a copy of all assignments in case of loss by any cause. Assignments cannot be returned by staff in the Department office.

Students showing noticeable improvement across assignments will be rounded up if their final grade falls between two letter grades.

PLAGIARISM

Plagiarism is an extremely serious offence. Please read the following information carefully. The penalty routinely recommended by the English Department for documented plagiarism is failure of the course in which the offence occurred; academic probation is also routinely applied at the Faculty level. Suspension or expulsion can result from severe or repeated plagiarism.

The University Calendar states:

- 1. Plagiarism Essentially plagiarism involves submitting or presenting work in a course as if it were the student's own work done expressly for that particular course when, in fact, it is not. Most commonly plagiarism exists when:
- (a) the work submitted or presented was done, in whole or in part, by an individual other than the one submitting or presenting the work (this includes having another impersonate the student or otherwise substituting the work of another for one's own in an examination or test),
- (b) parts of the work are taken from another source without reference to the original author,
- (c) the whole work (e.g., an essay) is copied from another source, and/or,
- (d) a student submits or presents work in one course which has also been submitted in another course (although it may be completely original with that student) without the knowledge of or prior agreement of the instructor involved.

While it is recognized that scholarly work often involves reference to the ideas, data and conclusions of other scholars, intellectual honesty requires that such references be explicitly and clearly noted.

Plagiarism occurs when direct quotations are taken from a source without specific acknowledgement, or when original ideas or data from the source are not acknowledged. Citing your sources in a bibliography is not enough, because a bibliography does not establish which parts of a student's work are taken from other sources. MLA (Modern Language Association) documentation or other recognized forms of citation must be used for this purpose. Advice on adequate documentation can be found at the following web sites:
