Course Description

The course is explores the main principles of real estate development. The goal is for students to gain a practical understanding of the players and processes in real estate development, including partnerships, the development and planning approvals processes, engagement with stakeholders, understanding market conditions and development impacts. This course introduces the basic skills for conducting a feasibility analysis on a site to determine the viability of a proposed real estate development project. Further, how to identify the opportunities and constraints of a site. Students will learn how to creatively and analytically approach real estate development and the major players involved.

The <u>teaching approach</u> will focus upon skills building through a mixture of lectures, readings, guest speakers, hands on application of skills to real world examples.

Course Hours: 3 units; (2-1Tutorial)

Online Delivery

Learning will occur in both synchronous (i.e., real-time/Zoom) and asynchronous (i.e., students complete on their own time such as discussion boards, watching videos, etc.) contexts.

This course will take place **online** via Desire2Learn (D2L) and Zoom. Students are required to participate in the asynchronous learning tasks using the D2L learning environment and synchronous Zoom sessions. If unable to participate live due to unforeseen circumstances, inform the instructor in advance to work out an alternative participation activity (e.g., watch the recordings, submit a brief reflection, and actively contribute to the follow-up online discussion).

- 2. Understand the relationship between architecture, planning and real estate development
- 3. Understand the role planners and architects play in real estate development
- 4. Understand the typical steps of the development process
- 5. Understand the significance of finance in real estate development
- 6. Understand the importance of data (i.e. demographic, economic) in assessing a project's feasibility
- 7. Understand the factors that positively and negatively influence and impact real estate development

Assignment #1: Development in the News Critique (Due: January 26)	Your task is to select a news article (online source is appropriate) that presents a development project either proposed or underway. Assignment #2: Site Selection Analysis (Due: February 23)	Through a series of pre-determined questions, students will compare and contrast the possibilities, opportunities, challenges, and merits of development across multiple sites located in Calgary. Students will be expected to draw on a wide range of insights that they have gathered throughout the course of their studies including: policy + land use regulations, marketing, finance, and community engagement	25%	1, 3, 4, 5, 6, 7
Assignment #3: Detailed Development Proposal (Due: April 13)	Your task is to choose a parcel of land (no larger than the block scale) within the Calgary context that offers the potential for development/redevelopment. Assignment #4: Detailed Development Presentation (Due: April 13)	Students should present as if they are pitching their proposal to an audience of potential investors. The presentation will include a period for questions and conclude with a recommendation as to whether investors should proceed or abandon the proposed development.
