#### **Official Course Description**

Physical laws governing wind processes in the upper atmosphere and the planetary boundary layer. Topics include: global wind patterns, boundary layer wind flow, pollution, wind energy, wind erosion, and wind storms.

#### **Course Objectives**

Students will learn about the physical processes driving large-scale atmospheric circulations, the interactions between wind and the Earth's surface, and they will gain a broader understanding of wind in applied situations.
