### **Official Course Description**

Implementation of a project on a GIS topic which will involve demonstrating mastery of GIS project design and the implementation and presentation of results commensurate with graduate-level work. This topic will relate to material covered by the student in Geography 681.

## **Course Objectives**

The main objectives of this course are to (i) guide students in the completion of their MGIS capstone project and (ii) to complete the MGIS oral comprehensive exam.

**Prerequisites:** Admission to the Graduate Certificate in Geospatial Information Technology or consent of the Department.
