3. **Grading:** The University policy on grading and related matters is described sections F.1 and F.2 of the online University Calendar. In determining the overall grade in the course the following weights will be used:

Assignments (4) 20%

Midterm tests (2, in class) 40% (October 16<sup>th</sup>, November 20<sup>th</sup>)

Final Examination 40% (To be scheduled by the Registrar)

A passing grade in the final exam is essential if the student is to pass the course as a whole (grade of C- or better).

Each piece of work (assignment, quizzes or final examination) submitted by the student will be assigned a percentage score. The student's average percentage score for the various components listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade [bearing in mind that grade of D+ or below will result if the student does not pass the final examination].
