#### Course Incomes:

- o Material from ASPH213/305 such as understanding of magnitudes, flux, intensity, distance determinations, orbital motion, astronomical coordinate systems, stellar composition and spectral types.
- o Material from PHYS 229 / 325 such as Electromagnetic waves, Blackbody radiation, Photoelectric Effect, Compton Scattering, Atomic Structure, The Bohr Model, and Atomic Spectra
- o Familiarity with calculus (including single, double and triple integrals) and differential equations (including partial differential equations)

#### Course Outcomes:

- o Understand the equations that relate pressure, density and temperature in a star in hydrostatic and local thermodynamic equilibrium for chemically homogeneous and inhomogeneous stars.
- o Relate the physical state of the gas in the interior of a star to evolutionary time scales and the observed distribution of stars in the Hertzsprung-Russell diagram.
- o Quantitatively evaluate the equation of state and physical processes such as nuclear fusion, convection, and radiation transport for plasma in equilibrium ionization under non-degenerate and degenerate conditions.
- o Discuss the late stages of stellar evolution as a function of mass, and how these relate to the creation of heavy elements and the dissemination of products of stellar nucleosynthesis into the interstellar medium.
- o Describe the main features of the spectra of stars in the spectral sequence OBAFGKM and understand the physical origin of spectral lines.
