COURSE INFORMATION

Here are two plausible claims: (i) Sherlock Holmes was created by Sir Arthur Conan Doyle, and (ii) Sherlock Holmes doesn't exist. Putting them together raises a puzzle: how can it be that Sherlock Holmes was both created, and doesn't exist? After all, it seems that if something was created then it exists (or at least existed). This is just one puzzle about the nature of art, which will be our focus this semester. We'll survey a variety of puzzles about the reality of books, symphonies, fictional characters, and other artworks, with an eye to drawing broader conclusions about the nature of creativity, existence, and the relationships between thought, language, and reality.

PREREQUISITE(S)

Admission to the Philosophy major and consent of the department.

Course Learning Outcomes:

Students who complete this course will have a grasp of some of the key theoretical issues that underlie the metaphysics of art. Students will be required to write and revise short papers, review their peer's work, and succinctly present key positions.

RECOMMENDED BOOK:

Philosophy Writing: A Guide for Canadian Students, by Lewis Vaughn and Jillian Scott McIntosh, Oxford University Press.

COURSE ASSESSMENT AND EVALUATION

Assessment Components and Grading Schemes

- Two exams, worth 25% of the grade each. They will be held on Oct. 3 and Nov. 5.
- One quiz, worth 15% of the grade. It will be held on Dec. 3
- Six short papers (approx. 500 words). Due dates: Sept. 12, 19, 26, Oct. 10, 24, Nov. 21. These are each worth 2% of the total grade, and full credit will be given for completion.
- One portfolio, consisting of two revised short papers. Due Dec. 10. Worth 20% of the grade.
- Participation, worth 3% of the grade.
- There is no registrar-scheduled final exam.
- No aids (including notes, books, or electronic devices) are allowed for the exams or quiz.
