## **Course Description**

Since this course is the integrative seminar for the Law and Society program, the overall goal is to permit students to bring to bear the whole range of their experience and knowledge in the Law and Society program to analyze social issues and design a research project that will accomplish these objectives.

# **Course Objectives**

By the end of the course students should be able to critically evaluate legal philosophical and theoretical texts and a variety of other materials as well as understand the way in which the law, politics, and society influence each other and how the law in Canada and other liberal democracies is made and reformed over time.

### **Assignments and Evaluation**

### **Course Participation**: 20%

- Class participation will be evaluated on the basis of your participation in course discussion.
- Discussion will take place during seminar-style debate, smaller group work, and in the message board of the D2L site.
- This is not a grade for attendance. Students should consider that participation is a way for you to demonstrate understanding of the texts and key concepts.
- Failure to participate will result in a failing grade on this portion of the course.

# Book Review 20% – due in class September 27

• This paper will be an analysis of one of the course texts. It should be constructed as a formal academic book review. This paper will have a word limit of 750 words.

### Abstract of Project and Early Bibliography 5% – Due in class October 4

• This assignment is a preliminary abstract and bibliography of your project. It is to help the instructor catch problems with your initial research and approach, or to suggest additional sources for your research.

## Conference-Style Presentation (20% of final grade) – Weeks 10-12.

- The last three weeks of the course will be taken up with student presentations of their final papers.
- These presentations will take the form of a mock academic conference. Students will present their research on panels with other students presenting on similar themes.
- Each presentation will be approximately 6 minutes in length with questions and discussion to follow. Your presentation date will be assigned to you after submission of your abstracts

#### **Research Project** 35% – due in class, December 8

The research project is designed to allow students to familiarize themselves with a specific area of sociolegal research, conceive of an original question (or gap in the literature) and work through the process of designing a response to this.

It is comprised of the following sections:

- **Abstract:** A one-page synopsis of the research question, keyfindings of the literature review, and discussion of methodology and limitations of the data.
- **Literature Review**: 2,500 words discussing the contributions of key scholars, debates in the field, and gaps in the existing literature.

- **Methodology:** 1,500-words discussing of theoretical approach and methodological approach that best addresses the research question.
- **Bibliography:** Annotated list of your sourcesd in Chicago style.

The paper should be set in Times New Roman 12 point font with standard margins.

Papers on other topics of law should not be considered.

All written assignments should be submitted to the electronic drop box.

#### Seminar Schedule and Format

Each week is set up in roughly the same format. The Tuesday class will involve a seminar discussion with the entire class. This means students must have the text read and comments prepared before class on Tuesday.

Thursday classes will be divided up into different exercises. These will include more detailed discussion of the texts based on questions provided by the instructor; workshops on academic skills and development (paper tutorials, peer review, conference practices); other assignments as developed by the instructor.

It is very important that you keep up to date with the D2L site from week to week. Assignments for the Thursday class will be posted each week so that students are aware of what is expected of them from week to week.

Writing skills include not only surface correctness (grammar, punctuation, sentence structure, etc) but also general clarity and organization. Research papers must be properly documented.

Where a grade on a particular assignment is expressed as a letter grade, it will normally be converted to a number using the midpoint of the scale. That is, A- would be converted to 87.5 for calculation purposes. F will be converted to zero.

Readers must be able to tell exactly where your words and ideas end and other people's words and ideas begin. This includes assignments submitted in non-traditional formats such as Web pages or visual media, and material taken from such sources.
