# SOCI 331.02 Classical Sociological Theory Fall 2015

#### **Course Description**

This is a required, core course for students majoring in Sociology. It has several objectives:

- 1) to provide you with an introduction to the intellectual and social history of the discipline. (How and when did it become possible to study "society" in a systematic way? What topics were important to early social theorists and sociologists? How did these topics emerge from the social, political and economic contexts of the time?);
- 2) to acquaint you with the key ideas of some of the most influential sociological theorists of the period 1830-1940, and to consider how these ideas have contributed to the development of sociology (some of these ideas are still in broad circulation while others have dropped to the margins why?);
- 3) to provide you with practical experience in reading original works of social theory and analysis (we'll work on this together in class);
- 4) to provide you with an opportunity to examine contemporary issues and practices (e.g., gender, racialization, consumer society, social media, inequality) through the lens of classical theory, thereby evaluating the continuing relevance of the theory while also building your skills as a critical sociologist.

#### **Course Readings**

Kenneth Allan, *Explorations in Classical Sociological Theory: Seeing the Social* World, 3<sup>rd</sup> edition (Thousand Oaks, CA: Sage, 2013).

A collection of excerpts from the original works of the theorists (available from the University of Calgary Book Store).

#### **Activities and Assessment**

**Exams:** The course is organized into three units, with a test after each unit. There are two midterm tests (October 6 and November 10) and a registrar-controlled final exam (date to be determined). Tests and the final exam will cover material from lectures, the textbook, and the theorists' original works; they will include fixed choice, short answer and essay questions.

Midterm tests #1 and #2 are not cumulative. Some parts of the final are cumulative.

*Essay:* This is a 2-3 page (1000 words maximum) essay due October 27. In this essay you will use ideas from classical theory to consider a contemporary situation. The topic will be assigned at least two weeks before the due date.

I am most likely to round a grade up when (a) the grade is more than halfway to the grade above *and* (b) the letter grade for the final exam is higher than the cumulative final grade for the course.

#### **Deferrals**
