Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

Course Outcomes:

- o Identify common minerals in igneous, metamorphic, and ore rocks using hand samples and thin sections.
- o Classify and name igneous and metamorphic rocks using mineralogy and texture.
- o Describe and interpret the textures and structures of igneous, metamorphic, and ore rocks in terms of geological processes.
- o Describe, in a general sense, how and where the main types of igneous, metamorphic and ore rocks form.
- o Write a complete mineralogical and textural description, with labelled sketch, of an igneous or metamorphic rock in hand sample or thin section.
- o Use phase diagrams to interpret some features of igneous and metamorphic rocks.
- o Operate a petrographic microscope in plane polarized and cross-polarized light.
