2. **Requisites:**

**Prerequisite(s):** Geology 401 and consent of the Department.

**Antirequisite(s):** Credit for Geology 441 and 639 will not be allowed.

**Notes:** This course occurs in rugged field conditions and varying weather, for which participants must be prepared and equipped. A supplementary fee will be assessed to cover additional costs associated with this course. Students will require consent of the department to drop this course.
