To account for any necessary transition to remote learning for the current semester, courses with in-person lectures, labs, or tutorials may be shifted to remote delivery for a certain period of time. In Person Delivery Details:

Lectures - Lectures will be conducted in person in the scheduled classroom. Students are expected to attend lecture sessions.

More information about safety protocols and other relevant information for in-person meetings will be provided to students prior to or during the first week of classes.

Laboratories - All laboratory sessions are currently scheduled in person to allow more hands-on learning. However, if it becomes necessary to address COVID-related safety concerns, the labs would transition to online learning. Regardless, the first four laboratory sessions of the term, as outlined below, will be conducted in person since they require direct visualization of key hydrogeology demonstrations. These in-person laboratory sessions will take place on:

Thursdays, Sept. 15, Sept. 22, Oct. 6, and Oct. 13

Due to the design of the course, a student can only miss one in-person laboratory session. Accommodations for this missed in-person lab will be made on a case-by-case basis and the student will be expected to learn the concepts in the missed session on their own time.
