2. **Requisites:**

Prerequisite(s): Geology 401 or 601 and consent of the Department.

Antirequisite(s): Credit for Geology 639 and 441 will not be allowed.

Notes: This course has limited enrolment. This course occurs in rugged field conditions and varying weather, for which participants must be prepared and equipped. A supplementary fee will be assessed to cover additional costs associated with this course. Students will require consent of the department to drop this course.

3. **Grading:**

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.
