## **Course Outcomes**

1. Identify the key parameters of a real world near surface geophysical problem and the data required to model the problem.
2. Write a brief review of the literature relevant to a near surface geophysical problem including giving proper reference to past work.
3. Develop a strategy for modelling a near-surface geophysical problem, including consideration of the geophysical techniques commonly applied to similar problems.
4. Design a solution to a near surface geophysical problem, supported by data and modelling results.
5. Write a scientific report describing the components of a solution to a near surface geophysical problem, as listed above.
6. Work in a small team to complete all deliverables of a project in a timely and professional manner.
