Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. Assignments require demonstrations. Students are expected to **demonstrate** their work during their **scheduled** labs.

Quizzes are done during **scheduled lectures**. Each quiz is designed to be completed between 30 to 45 minutes, but students will be given 2.5 hours to work on it. Question(s) will be released on D2L at noon, and the submission deadline will be 2:30 p.m. Note that Lec 1 is scheduled from noon to 12:50 p.m. and Lec 2 is scheduled from 1:00 p.m. to 1:50 p.m. The instructor will be available during both lectures (in the corresponding Zoom rooms) to answer clarification questions.

A student wishing a reappraisal, should first attempt to review the graded work with the Course coordinator/instructor or department offering the course.
