COURSE DESCRIPTION

Primate behaviour and related topics, including social dynamics, sociobiology, socio-ecology, dominance, aggression, kinship, sexual behaviour, socialization, learning, cognition, communication, ape language, and conservation. Course Objectives: This course will cover the fundamentals of primate behaviour research and theory, including evolution, social dynamics, socio-ecology, dominance, aggression, kinship, sexual behaviour, reproductive strategies, cognition, communication and conservation. You will learn primate taxonomy and be able to apply these concepts to conceptualize and describe ecological and behavioural variation exhibited across primate groups.

COURSE REQUIREMENTS AND ASSESSMENT

Evaluation for this course will be in person and include 2 mid-term exams and 1 final exam. All exams will be multiple-choice (which may include 'true or false' questions).

Test 1 – 30% - Feb 7 @ 6:00- 7:15 pm

This exam will cover all lectures, videos and assigned readings to date (Jan 10 –Jan 31). There will be a class/movie after the test.

Test 2 – 30% - Mar 14 @ 6:00- 7:15 pm

This exam will cover all lectures, videos and assigned readings to date (Feb 7[Movie] – Mar 7). There will be a class/movie after the test.

Final Exam – 40%- SET BY THE REGISTRAR April 15-26

The final exam is cumulative. This exam covers all lectures (ppt) from Jan 10 to April 11, excluding movies, required readings and testable videos from Test 1 and Test 2 sections. The Final includes movies, required readings and testable videos from the Final Exam section (Mar 14 [Movie]-April 11).

- **The tests for this class are ‘closed’ book.**
- Students will have 1 attempt per test.
- **MISSED MID-TERM EXAMS:** In the event of missing a mid-term test, contact the instructor within 48 hours of the missed exam (tsaj@ucalgary.ca).
