ARCHAEOLOGY OF SOUTH AMERICA: THE CENTRAL ANDES MWF 1:00-1:50 Location: ST 130

This course is designed to introduce students to the prehistory of the Central Peruvian Andes region of South America. Drawing on a combination of ethnohistorical and archaeological evidence we will explore and critically evaluate cultural developments in the region beginning with the first appearance of human groups through to the time of Spanish Conquest (early 16th century A.D.).

Course Objectives:

Students are expected to apply scholarly research and critical thinking skills to assess both controversial issues and accepted interpretations regarding Andean prehistory (e.g., the origins of agriculture, the development of complex societies, trade, warfare, etc.). Further, to evaluate and reflect on the evidence, methodology, and theoretical frameworks which have shaped these interpretations. The overarching objective is for students to develop their own opinions and to support them logically.

Course Format:

Lectures, readings, web- and library-based research, as well as class discussions will comprise the key learning activities involved in this course. All course-related materials beyond this syllabus will be discussed in class and posted under "Course Information" on Blackboard. Please note that materials designed specifically for lecture purposes (e.g., PowerPoint slides) will NOT be posted; students are expected to attend classes for access to this material.

Assessment:

Final course marks are assessed through the following six components:

- 1. Map Quiz 10% (Friday October 1, 2010)
- 2. Article Critique 10% (Friday October 15, 2010)
- 3. Midterm Exam 20% (Friday October 29, 2010)
- 4. Annotated Bibliography 20% (Friday November 26, 2010)
- 5. Final Take-Home Exam 35% (due by noon on Monday December 13, 2010)
- 6. Attendance and Participation 5%

Map Quiz: For the map quiz you will be expected to demonstrate familiarity with the geography of the Central Andes and to identify the locations of relevant geographical features (e.g., river valleys, environmental zones, etc.). Further directions about the map quiz will be provided in lectures.

Midterm: The midterm exam will consist of multiple-choice, identification of terms (definitions), and short answer questions.

Final Take-Home Exam: The take-home final consists of and essay-style written response. Your answer should demonstrate critical thinking, be well thought out, organized and well written. You will be given more than one question from which to choose. The exam and the official exam booklet will be provided on the last scheduled class. Students must pick up their own exam booklet and provide their UCID card. The completed exam booklet is to be submitted to the "tower" located outside the main office in the Department of Archaeology (ES 806) on or before noon on the due date.

Grading:

Each assessment component (e.g., quiz, article critique, etc.) will be marked and assigned a numerical grade. The result of each assessment will be posted electronically via Blackboard as soon as possible following grading by your instructor. The final cumulative grade is translated from a percentage to the University of Calgary's letter grading system as follows:
