Course description:

This class is a seminar that focuses on ethnohistoric and ethnographic studies of indigenous cultures in Mesoamerica. We will cover five broadly conceived topics. The class format includes a lecture to introduce each topic, but emphasis will be placed on discussion of readings. Consequently, class participation is very important.

Course Grading:

Readings and class participation (10%):

Each week, you will be given a list of readings that you will be expected to read for discussion the following week. We will read between two and three articles for each class, which does not involve a lecture. This is the equivalent of approximately 100-150 pages a week. You will be expected to be prepared for and contribute to the discussion of all articles.

Leading article discussions (15%):

Three times during the semester you will be required to lead the class discussion of an article or book chapter. This should include a brief summation of the article's major points (5 minutes) and the presentation of two discussion questions lead the class to debate or analyze the strength of the article's arguments, interpretations, and/or conclusions.

Critiques (35%):

For each of the five topics covered in class, you are required to submit a critique of the three related articles or chapters. This critique should highlight the common thread among the articles. It should also note the strength or weakness of the data presented, as well as the arguments and the conclusions reached. These summaries should be approximately 1000 words in length. They are due one week after the topic has been completed, so you have the benefit of the discussion to help you with your paper. Information on how to write a critique will be posted on D2L.

Presentation of research paper (15%):

The final presentation will cover your research paper and should be 20 minutes in length with an additional 5 minutes for questions. A detailed guidelines for presentations and a grading rubric will be posted on D2L

Final Research Paper, due the last day of classes (25%):

Your final paper should be approximately 15-18 pages in length and address the same topic as your presentation. Your paper is due on the last day of class. If the paper is submitted after the deadline, 5% of the grade will be subtracted for each subsequent day.

Your paper should present a strong thesis statement. This is a question or a problem that you intend to address in your paper. Your paper should be thoroughly researched, well organized, and well written. Your argument should be supported with points from the literature and your conclusions should be based on the data you present in your paper. Detailed paper guidelines and a grading rubric will be posted on D2L.

If you have never written a research paper like this before, please make an appointment to see me or go to the writing center in Mac Hall for help.

It is not essential to pass all components to pass the course as whole.

There is no final examination for this course.

Missed or Late Assignments

Official excused absences (as per university policy) must be reported to the instructor within 24 hours.

Students with official excused absences will be given an opportunity to reschedule their <u>discussion leadership</u> when possible. If rescheduling is not possible, the students may submit an additional written critique.

Research papers and critiques may only be turned in late with an official excuse as per university policy. Unforeseen emergency or situations should be reported to the professor as soon as possible. Alternative arrangements will be based on individual circumstances.
