

ARKY 555 (LEC01) Human Osteology GFC Hours 3-2 Winter 2024

Prerequisite(s): ANTH 309, ANTH 350, or ARKY 417.

COURSE DESCRIPTION

Identification and interpretation of human skeletal and dental remains. Emphasis is on functional anatomy and reconstruction of prehistoric lifeways.

LEARNING OUTCOMES:

The Department of Anthropology and Archaeology is committed to student knowledge and skill development.

Upon completion of this course, students should be able to:

- List the main ethical responsibilities of those who study and curate human remains
- Correctly identify the elements of the human skeleton and their associated landmarks on anatomical models, on bone or teeth, and/or in illustrations
- Correctly distinguish between the elements from juvenile and adult skeletons
- Describe the structure and function of bone as a living tissue
- Describe the main processes involved with the growth and development of bone and the dentition
- Correctly apply and interpret standard techniques for estimating age, sex, and stature
- Distinguish between expected skeletal variation and common disease, traumatic, or taphonomic processes that affect bone
- Describe the basic applications of current bioarchaeological research (including, but not limited to, paleodemographic analyses, biological distance, and dietary reconstruction)

READINGS AND TEXTBOOKS:

- **Required.** The Human Bone Manual (2005). Tim. D. White and Pieter A. Folkens. Academic Press.
- Additional **required** and recommended readings as indicated in the Schedule below. Links will be provided on D2L.

COURSE REQUIREMENTS AND ASSESSMENT

EXAMS

1) Lab Practical Quizzes

- These will be held during regular scheduled class times. Practicals consist of bellringer questions held at a number of stations in the room. You will have a short amount of time (usually 60-90 seconds) to identify the bone and answer any other questions at that particular station before moving to the next.
- These lab practicals are closed book.

2) Midterm Exam

- The ARKY 555 midterm will consist of multiple choice, diagram labeling, and short answer questions.
- The exam will cover material from the first class up until and including the Feb 12th class, including assigned readings.
- The midterm is closed book.

3) Final Exam

- The final exam will have a similar format to the midterm exam (multiple choice, short answer, and labeling diagram questions).
- Content will be cumulative for the entire course.
- The final exam is closed book.

ASSIGNMENT

Osteobiography Lab Report

- a. This written report contains your assessments and interpretations of skeletal remains from the teaching collection, using the techniques we've covered in class.
- b. Access to materials will occur beginning March 4th and extend until April 11th.
- c. Specific grading expectations and criteria are posted on D2L and will be discussed further in class.
- d. The lab report is to be handed in via the D2L Dropbox.
- e. Late submissions will not be accepted without prior instructor approval.

Missed examinations/tests cannot be made up without the approval of the instructor. Exams may only be deferred in the case of serious illness or medical emergency, religious observance, or domestic affliction (see: <u>https://www.ucalgary.ca/registrar/exams/deferred-final-exams</u>).

Students who miss a test/exam have up to **48 hours from the scheduled start of the exam** to contact the instructor to ask for a makeup test/exam. Students who do not schedule a makeup test/exam with the instructor within this 48-hour period forfeit the right to a makeup test/exam and will receive a mark of zero on the exam or assignment.

Makeup tests/exams may differ significantly (in form and/or content) from the regularly scheduled test/exam. For ARKY 555, this may involve long-answer or essay-style questions rather than multiple choice. Once approved by the instructor, a makeup test/exam must be written within **two weeks** of the missed test/exam on a day/time scheduled by the instructor.

Students may be asked to provide supporting documentation for an exemption/special request. This may include, but is not limited to, a prolonged absence from a course where participation is required, a missed course assessment, a deferred examination, or an appeal. Students are encouraged to submit documentation that will support their situation. Supporting documentation may be dependent on the reason noted in their personal statement/explanation provided to explain their situation. This could be medical certificate/documentation, references, police reports, invitation letter, or a statutory declaration, etc. The decision to provide supporting documentation that best suits the situation is at the discretion of the student. Students cannot be required to provide specific supporting documentation, such as a medical note. Falsification of any supporting documentation will be taken very seriously and may result in disciplinary action through the Academic Discipline regulations or the Student Non-Academic Misconduct policy.
