- research information about architectural figures, structures, themes and significant aspects, as well as contemporary connections to historical examples;
- collaborate in a group project responsibly, respectfully and critically;
- identify and structure thematic connections between architectural works and figures within a conceptual context;
- reflect on their own learning.

This assignment is intended for learners to become aware of the continuities, the differences and changes of themes and concerns of architects and structures across time and movements covered in this course. Please **work through** the posted course material [texts and visual presentations] and **select 5 major themes**, **concepts or concerns** covered in each lecture topic [list of topics and list of theme examples are posted on D2L: content → assignments → learning log].

For each topic, **name one structure [building or project]** from the course material which YOU consider the <u>most significant</u>, and **argue for and explain this significance** by describing what triggered this selection [e.g. material, design, composition, impact, meaning,...], what does this structure remind YOU of [could be related to a previous experience you had], and what this structure tells YOU about the time of building/conception. When you are assigned to a group, please start your research on this topic and **post your initial findings** [present a <u>summary and evaluation</u> of your sources, could be websites, videos, documentaries or academic articles] **to your group-member on D2L by Monday, 19 October 2020, 11:30 pm**, <u>no</u> extension is possible.

The group will communicate by any chosen medium, and debate which findings are credible and from reliable sources, where they possibly need to do further research in order to present interesting and academically valid information to the entire class.

This assignment is intended to foster the identification and analysis of issues & concerns connected to movements, architects and structures in order to create a system of conceptual relations.

Please select <u>one</u> topic of the posted topic list [D2L content  $\rightarrow$  assignments  $\rightarrow$  concept map] and create a concept-map showing clearly <u>all</u> connections between your identified issues, concerns and movement, as well as exemplary works and architects.

Your concept map needs to show at least 15 visuals pertaining to your chosen topic and 5 additional visuals from the 21<sup>st</sup> century [= current global visual culture] that can be connected to your topic [all connections need to be labelled]. Each visual needs to include the name of the structure/project/work, architect, and date.

The grade for this assignment will be predicated by your adherence to the expected format, the visual impact [above all clarity, e.g. use color codes and symbols] and content complexity [e.g. diversity of examples].
