Introduces students to 3D modelling by means of digital sculpting techniques, their historical context and terminology. Provides a focus on the fundamentals of working and designing in three-dimensional space.

# **Objectives of the Course**

Students should be able to design, model, and prepare for output three-dimensional digital models created via a sculpting paradigm, as well as create basic modeling-paradigm objects for later sculpting.
