Course Description

Students explore an expanded field of painting through installing and contextualizing their work. This may include pictorial, spatial, performative, and conceptual responses to site. Students may engage in collage/assemblage, shaped canvases, text/image, objects, paint, and unconventional materials.

Art 231 or 241

Objectives of the Course

Course objectives include the acquisition of further skills and insights into the painting experience through studio work initiated by both the student and professor. The objective of the slide seminars, lectures, and critiques is to advance the student's critical understanding of painting in the context of the function of art in society; and to express these insights through a studio base. The course will attempt to produce student participants who are self-motivated, confident in their aspirations, competent in their chosen methodologies, demonstrate clarity of concepts and are able to produce a body of high quality work. It is expected that portfolio submissions will reflect a minimum commitment of ten hours per week.

Assignments and Evaluation

There is no final examination in this course.

Depending on complexity, assignments throughout the course are of different durations. A mark will be assigned at the termination of each assignment, which are approximately, but not necessarily four classes long.

Marks are based on term work that will be broken down into six separate periods

Assessment procedures and requirements-computation of final grade

Period one due Sept. 24 -10% painting, 5% participation

Period two due Oct. 8 10% painting, 5% participation

Period three due Oct. 22 -10% painting, 5% participation

Mid-term mark notification – October 29

Period four due Nov. 5 - 10% painting, 5% participation
Period five due Nov. 21 - 10% painting, 5% participation
Period six due Dec. 5 - 10% painting, 5% participation

Final presentation of term work Dec. 5 -10%

Each assignment mark will be broken down into 3 components - TCP (technique, creativity, problem solution)

There may be more than one component in each of the assignment categories.

If students miss a required component of the course, it is their responsibility to contact the instructor immediately by email to discuss options.

It is not necessary to achieve a passing grade on any particular component of the course in order to pass the course as a whole.
