Course Description

This course introduces students to the fundamental elements of the Canadian legal system. The course is divided into two parts. Part I provides an introduction to the nature of law, the historical evolution of the Canadian legal system, and legal personnel and the court structure. Part II covers the theories, concepts, structures, and processes of select aspects of Canadian public and private law including constitutional, criminal, contract, and tort law, and provides a brief introduction to aspects of global governance and legal institutions such as the United Nations the International Court of Justice and the International Criminal Court, as well as international law concerning human rights, the use of force, and the peaceful resolution of conflicts between and within states.

Objectives of the Course

The objective of the course is to provide students with fundamental legal knowledge in key areas of Canadian law and the legal system.
