<sup>1</sup> Midterm 1 will be designed to be completed in 50 min, but you will also be given the 50% buffer time (25 min), so you will have the whole class time to write the exam.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.
