Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

This course will have a Registrar Scheduled Final exam that will be delivered in-person and on campus. <u>The Final</u> <u>Examination Schedule</u> will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 2 hours.

Final grades will be reported as calculated to two decimal places, and the grades will not be subjected to further rounding up or down after they are released. A maximum course letter grade of D+ will result if the student does not earn 50% or higher on the Laboratory component of the course (including the lab exam), and/or the weighted average of the Lecture Midterm and Final Exams, or does not complete these elements of the course.

A student wishing a reappraisal, should first attempt to review the graded work with the Course coordinator/instructor or department offering the course. The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected. Course Outcomes:

- Explain why DNA is the genetic material in organisms and describe how DNA information is expressed in cells
- $\circ\,$ Explain how and why mutations occur and the relationship between mutations and evolution by natural selection
- Differentiate among the theories of evolution, the cell theory, and inheritance as uniting principles in biology and compare their historical contexts and evidence
- Analyze the implications, influences and major ways scientists study the theory of evolution
- Contrast single-gene dominant and recessive inheritance and recognize that phenotypes are not all singlegene phenomena
- Evaluate the relationship between environmental/climate changes and evolutionary changes over time
- Analyze phylogenetic trees and explain how they are made
- Collaborate with peers to describe, design and carry out scientific experiments
- Analyze scientific data collected from scientific experiments (student-conducted experiments and experiments described in the primary literature)
- Produce oral and written reports that communicate scientific information effectively
