⁴ The test will be taken online. The online test will be designed to take no more than 45 min to write, but you will have the 50% buffer time added, and will have the whole class time for writing the test.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. Students perform dissections on dead or preserved organisms in some courses. In particular courses, students experiment on living organisms, their tissues, cells, or molecules. Sometimes field work requires students to collect a variety of living materials by many methods, including humane trapping.

The Department strives for the highest ethical standards consistent with stewardship of the environment for organisms whose use is not governed by statutory authority. receiving the decision from the instructor. The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
