Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. Sometimes field work requires students to collect a variety of living materials by many methods, including humane trapping.

The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected. - Generate hypotheses and predictions about the likely outcomes of various management practices and policies that potentially affect single species or biodiversity

- Analyze the differences and complementarities of species- and habitat-based conservation approaches
- Apply ecological and evolutionary theories and methodologies to solving problems related to conservation of biodiversity, including threats to single species and to communities
