¹ This portion of the grade will consist of the instructors' evaluation of: a) student participation in field exercises and discussions on the trip and during the preparation week, and b) a field notebook, recording events of interest or significance which occur during the trip. The notebook is due Sunday 29 May prior to the departure from Lamanai.

² Oral presentations will take place in class. *Should the university mandate us to go remote, the oral taxon reports will be synchronous online, during regular class time on this date.

³ This will consist of a 60-minute quiz on Friday, 13 May on material from the readings and lectures during the on-campus preparation week. **Should the university mandate us to go remote, the midterm will be synchronous online, during regular class time on this date.

⁴ Three-page (double-spaced) paper on a group of animals or plants which may be encountered at the study site at which we will be staying and which is either unique to, or much more common in, tropical areas than other places where you have spent time (i.e. Alberta/Canada). There will be a list of suggested taxa available on Monday of the on-campus week. Information sources will be available in BI 211 or you can use other material in the library or online. Oral presentations will take place on Friday, 13 May. Written due Saturday, 14 May by 5pm.

⁵ Students will provide a two- to three-page (double spaced) summary of a relevant research paper dealing with biodiversity and conservation issues in Belize or the tropics (preferably the Neotropics). A variety of titles will be available for you to consider, or you may choose one of your own provided it is: a) recent and b) approved by the instructors. You will be asked to do an oral summary of the contents of the paper while at the field site. You may turn in the written component at any time prior to the departure from Lamanai.

⁶ Students will prepare a brief oral proposal for a short-term project, collect data to address the question in the proposal, and write a report on the project. Topics for projects may be selected by students from a suggested list or proposed independently, subject to approval by the instructors. Students will work in small groups. Groups will give a brief presentation of their project on the last one or two evenings. The report/paper will be due on Saturday, 28 May by 4 pm.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

- be able to list the different method(s) used to survey animals and plants of different types, and be proficient using some of these in the field
- be better able to plan and implement a research project with others, by developing an hypothesis and predictions and testing those under field conditions
- be better able to work effectively as part of a team, provide constructive feedback to team members and demonstrate collaborative report writing
- have improved oral and written communication skills
- be better at managing time effectively in a highly focused and less familiar learning environment
