Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

Note: A maximum course letter grade of D+ will result if a student has unexcused absences from 2 or more laboratory sessions and/or does not pass (>50%):

- 1. The combined average of the two laboratory exams (refer to the laboratory schedule below)
- 2. The laboratory component of the course

This course will have a Registrar Scheduled Final exam that will be delivered in-person and on campus. <u>The Final Examination</u> <u>Schedule</u> will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 2 hours.

Note: The final percent course grade will be reported to 2 decimal places (*i.e.*, 79.65%) and course grades will not be rounded, curved, scaled, or manipulated in any way. There is no opportunity for replacement, make-up, extra, or bonus course work.

4. Missed Components Of Term Work:

In the event that a student legitimately fails to submit any online or in-person assessment on time (e.g. due to illness, domestic affliction, etc...), please contact the course coordinator, or the course instructor if this course does not have a coordinator to arrange for a re-adjustment of a submission date, or possible exemption and reweighing of components. Absences not reported within 48 hours will not be accommodated. Students may be asked to provide supporting documentation (<u>Section M.1</u>) for an excused absence, See <u>FAQ</u>.

If an excused absence is approved, options for how the missed assessment is dealt with is at the discretion of the coordinator or course instructor. Some options such as an exemption and pro-rating among the components of the course may not be a viable option based on the design of this course.

Lab Attendance Policy: Attendance is required at all laboratory sessions for the duration of the scheduled lab time, and you may only attend your registered lab section due to space, equipment, and safety limitations. If you miss, or are late for, a lab, you must contact the lab coordinator before, on the same day as the missed session, or within 48 hours for unforeseen circumstances. Only valid reasons for absences/lates will be accepted and will be considered on a case-by-case basis. If you miss a lab, you are still responsible for the material covered in the missed session. A student with absences from 2 or more lab sessions, a grade < 50% of the combined average of both lab exams, or a grade < 50% in the lab component of the course, will receive a maximum grade of D+.

5. Scheduled Out-of-Class Activities:

There are no scheduled out of class activities for this course.

Throughout the month of March (refer to the lab schedule below), students will complete a lab project that requires them to maintain cultures (incubation, storage, *etc.*) throughout the exercise. Students must return to the lab outside of scheduled lab times to manage their cultures. Details are provided on D2L.

11. Reappraisal Of Grades:

A student wishing a reappraisal, should first attempt to review the graded work with the Course coordinator/instructor or department offering the course. - a. **Term Work:** The student should present their rationale a s effectively and as fully as possible to the Course coordinator/instructor within **ten business days** of either being notified about the mark, or of the item's return to the class. If the student is not satisfied with the outcome, the student shall submit the Reappraisal of Graded Term work form to the department in which the course is offered within 2 business days of receiving the decision from the instructor. The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected. See sections I.1 and I.2 of the University Calendar

Reappraisal requests should first go to the laboratory TA and next to the Lab Coordinator before proceeding to the Department.
