Tentatively, there are 11 lab reports planned. This number could be less and will be communicated to students during the semester.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

#### **EXAMS:**

Midterm exams (1 & 2) will be in person on January 30 & April 4, during regular class time.

This course has a registrar scheduled in person final exam. The writing time for the final exam is two hours.

A mark of greater than or equal to 50% is required on the laboratory portion of this course (all components except the exams) to pass the course as a whole.

Lab reports are usually due one week after the lab.

# 11. Reappraisal Of Grades:

A student wishing a reappraisal, should first attempt to review the graded work with the Course coordinator/instructor or department offering the course. The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
