An introduction to the fundamentals of brain function for students outside of the Neuroscience program. Students completing this course will be able to describe the molecular, cellular and systems underpinnings nervous systems functioning. Students will be able to discuss the functioning of brain systems underlying sensation, cognition, behaviour, and disease.

To account for any necessary transition to remote learning for the current semester, courses with in-person lectures, labs, or tutorials may be shifted to remote delivery for a certain period of time. In addition, adjustments may be made to the modality and format of assessments and deadlines, as well as to other course components and/or requirements, so that all coursework tasks are in line with the necessary and evolving health precautions for all involved (students and staff).

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

To determine final letter grades, final percentage grades will be rounded up or down to the nearest whole percentage. For example, a percentage score equal or larger than 89.5% will be rounded up to 90% = A, a percentage score smaller than 89.5% will be rounded down to 89% = A-.

This course will have a Registrar Scheduled Final exam that will be delivered in-person and on campus. The final exam for this course will be designed to be completed within 2 hours.

Students perform dissections on dead or preserved organisms in some courses. In particular courses, students experiment on living organisms, their tissues, cells, or molecules. Sometimes field work requires students to collect a variety of living materials by many methods, including humane trapping.

The program strives for the highest ethical standards consistent with stewardship of the environment for organisms whose use is not governed by statutory authority. The Department will arrange for a reappraisal of the work within the next ten business days. The reappraisal will only be considered if the student provides a detailed rationale that outlines where and for what reason an error is suspected.
