NEUR 507.35 introduces the process and industry of drug development, how drugs work, and how the body processes drugs, focusing on the nervous system. Through a combination of lectures and presentations by experts in the field, participants will acquire insights into the identity, physiology, and pharmacology of therapeutic targets in the nervous system, fundamentals of cell signaling mechanisms, the drug design process, concepts of rational drug design, and the unique pharmacokinetic challenges of the nervous system.

To account for any necessary transition to remote learning for the current semester, courses with in-person lectures, labs, or tutorials may be shifted to remote delivery for a certain period of time. In addition, adjustments may be made to the modality and format of assessments and deadlines, as well as to other course components and/or requirements, so that all coursework tasks are in line with the necessary and evolving health precautions for all involved (students and staff).

Online Delivery Details:

This course is being offered online in real-time via scheduled meeting times, you are required to be online at the same time.

To help ensure Zoom sessions are private, do not share the Zoom link or password with others, or on any social media platforms. Zoom links and passwords are only intended for students registered in the course. Zoom recordings and materials presented in Zoom, including any teaching materials, must not be shared, distributed or published without the instructor's permission.

The course will be delivered in online format only through the use of the Zoom platform. Lectures will be recorded and posted on the course D2L site within 48 hrs after their delivery. Student presentations will be recorded and made available to each presenter and, with their permission, to the rest of the class within 48 hrs of their delivery.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

To determine final letter grades, final percentage grades will be rounded up or down to the nearest whole percentage. For example, a percentage score equal to or larger than 89.50% will be rounded up to 90% = A; a percentage score smaller than 89.50% will be rounded down to 89% = A-.
