## **Course Description**

Individual research and seminar activities (e.g., critiques, presentations, and peer reviews of drafts) to produce a proposal and a paper to be used as the basis for the Honours Thesis.

## **Additional Information**

This course requires student participation in two components, biweekly synchronous seminar activities and independent research:

1) The 595 seminar provides a collegial and supportive environment for discussion of thesisrelated skills and issues. Students will take part in group critiques, individual presentations, and peer review of draft chapters.

2) Students will also write an extended proposal and paper, which will form the basis for the Honours Thesis. These writing projects will be executed under the supervision of a faculty member and co-direction of the honours program coordinator.

Note: Communication and Media Studies 313 or Communication Studies 313 and admission to the Honours Program is required.

Please note that the Honours Seminar meets <u>every two weeks</u> in Fall. Please make a standing appointment to meet your supervisor in the intervening weeks.

Refer to the schedule of meeting dates (and topics) found at the end of this outline or on D2L. Students are responsible for reading and following all course and university policies discussed in this outline.

# **Objectives of the Course**

The course objectives are to:

- Conduct a senior undergraduate-level independent research project, culminating in an expanded honours thesis proposal and complete literature review and/or theory chapter.
- Understand various research methods, thesis research and writing processes, and thesis structures and styles through peer review, seminar activities, and thesis-related assignments.
- Effectively present one's research in a written document and oral presentation format.

# **Textbooks and Readings**

No textbooks are required, however students will be required to read materials for their thesis and to review each other's drafts and presentations.

# Learning Technologies and Requirements & Policy on the Use of Electronic Communication Devices

This is an online course. In order to complete online (or blended) courses, University of Calgary students are required to have reliable access to the following technology:

15%	<b>Previous Thesis Study</b> (4-5 pages) Students will select two Honours Theses (one Film, one Coms) from the Honours website (https://commfilm.ucalgary.ca/undergraduate/honours-program). Students must read both theses and prepare detailed notes that compare and contrast the theses' structure and argument development.	Sept. 24
	Your notes will be submitted for assessment, and will form the basis of a group discussion about the structure of Honours Theses for the two disciplines.	

15%	Thesis Project PresentationStudents will prepare a 10-minute presentation describing their honours thesis projects, based on initial research and conceptualization of the project. These presentations will be evaluated on the suitability of the presentation format, the clarity of the ideas communicated, and the ability of the presenter to field questions about their research.Student presentations will take place synchronously during one of our regularly scheduled Zoom classes. (If preferred, students may upload narrated PPTs or a video prior to class).	Oct. 8
25%	Honours Thesis Proposal & Bibliography (5 pages) Students must prepare an expanded honours thesis proposal (with bibliography & timeline). This proposal may be based on the initial proposal used to gain admittance to the honours program, but must be developed more fully through additional research and more advanced conceptualization of the project. This proposal should demonstrate the feasibility of the honours research by stating the key research question(s), identifying the key theories and/or literatures to be used, describing the methodological approach (ex. what will be analyzed? how will it be analyzed?), and producing a clear timeline to completion. 5%	<b>Peer Review: Chapter Posting</b> Students need to upload one thesis chapter to D2L for peer review by Nov. 16. All submissions should be read prior to meeting as a group on Nov. 19.	Nov. 16
25%	Peer Review SessionStudents are expected to produce a draft of at least one thesis chapter during the fallterm. The seminar provides an opportunity to conduct a peer review of one chapter.Participation in the peer review process entails pre-reading each other's drafts,preparing written and verbal feedback (notes) on the draft, and constructivelydiscussing each other's work during a peer review session.The peer review session will take place synchronously, via Zoom break-out rooms. 15%	<b>Progress Reports</b> Students' participation in the Honours Seminar will be measured by their active engagement in group discussion and class activities. Specifically, on days when progress reports are due, students should come prepared to share a status update on their thesis work. These progress reports will be delivered verbally during synchronous sessions on: October 22, November 5, and December 3. Each report is worth 5 points.	Oct. 22 Nov. 5 Dec. 3

# Plagiarism

Using any source whatsoever without clearly documenting it is a serious academic offense. Consequences include failure on the assignment, failure in the course and possibly suspension or expulsion from the university. These requirements apply to all assignments and sources, including those in non-traditional formats such as Web pages or visual media.

You must document not only direct quotations but also paraphrases and ideas where they appear in your text. A reference list at the end is insufficient by itself. **In-text citations must be provided, and readers must be able to tell exactly where your words and ideas end and other people's words and ideas begin**. Wording taken directly from a source must be enclosed within quotation marks (or, for long quotations, presented in the format prescribed by the documentation style you are using). Paraphrased information must not follow the original wording and sentence structure with only slight word substitutions here and there.

- By the October deadline, submit your ethics application to the Faculty of Arts Research Ethics Committee. Seek the guidance of your thesis supervisor and obtain their approval of your application. Include the Tri-Council certificate of completion in your application.

After submitting the application to the Faculty of Arts, be prepared to submit revisions requested by the committee; the review may take several weeks to process.
