There are five equally weighted tutorial quizzes (worth 4% each). These are online quizzes to be completed during your scheduled tutorial period (12pm in SA204 on either Tuesday, or Wednesday, or Friday). You must provide student ID and sign in when completing these guizzes. The five guizzes happen in the weeks starting Jan 22, Feb 5, Feb 26, Mar 11, Apr 1.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

Students will be expected to understand at every stage the material covered in all components of the course. In order to satisfy the prerequisite requirements (i.e., C-) for further Chemistry courses, a student must achieve either a minimum 50% on the Final examination, or a minimum 50% weighted average on the examinations (Two Midterm exams and Final exam).

The coursework mark is based five equally weighted quizzes. A classroom participation score based on participation during inclass Top Hat questions may be used to replace the lowest non-zero tutorial quiz score at the end of term.

A grade of D+ or below will result if a student scores below 50% on the final examination and also scores below 50% on the weighted average of the two midterm and final examinations.

This course will have a Registrar Scheduled Final exam that will be delivered in-person and on campus. The Final Examination Schedule will be published by the Registrar's Office approximately one month after the start of the term. The final exam for this course will be designed to be completed within 2 hours.

## 4. Missed Components Of Term Work:

In the event that a student legitimately fails to submit any online or in-person assessment on time (e.g. due to illness, domestic affliction, etc...), please contact the course coordinator, or the course instructor if this course does not have a coordinator to arrange for a re-adjustment of a submission date, or possible exemption and reweighing of components. Absences not reported within 48 hours will not be accommodated. Students may be asked to provide supporting documentation (Section M.1) for an excused absence. See FAQ.

If an excused absence is approved, options for how the missed assessment is dealt with is at the discretion of the coordinator or course instructor. Some options such as an exemption and pro-rating among the components of the course may not be a viable option based on the design of this course.

There are no deferred Midterm examinations or deferred coursework assignments.

Absences must be reported within 48 hrs. If a student misses the midterm or a coursework assignment for reasons other than illness (e.g. varsity sports or academic conferences) then appropriate documentation is required. The course coordinator must be provided with any original documentation (not an electronic copy). The documentation must be provided to the course coordinator within 15 days of the date of the midterm or coursework assignment in order for an excused absence to be considered. If an excused absence is approved, then the percentage weight of a legitimately missed midterm examination will be shifted to the final examination; for coursework assignment this will be pro-rated among the remaining components of the coursework. (see Section E.3 of the University Calendar). If a student missed the midterm or tutorial assignment for non-legitimate reasons (e.g. vacation), the score of that course component will be zero.
