Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

4. Missed Components Of Term Work:

There is no deferred quiz option. If you miss a single quiz, the remaining 3 quizzes will count for 20% of your final grade with the highest one worth 10% and each of the other two worth 5% each. If you are unable to write any additional quiz(zes) during the scheduled time, notify your instructor either 10 business days in advance for scheduled absences or course conflicts, or within 48h of the missed quiz for emergency absences. The weight of any legitimately missed additional quiz(zes) will be shifted to the final exam.

There is no deferred midterm option. Course Outcomes:

- o Understand periodicity in the groups 1, 2, and 13-18 of the periodic table and the implications for electron-poor and electron-rich elements with regard to structure, bonding, and stability (thermodynamic + kinetic)
- o Identify classical and non-classical (multicentre-multielectron) bonding
- o Understand structure, bonding, and reactivity of main group element-based molecules, including subvalent and hypervalent species
- o Relate heteronuclear NMR spectra as well as X-ray crystallographic data of substances to molecular structure and chemical bonding
- o Apply molecular orbital theory to derive bonding features in main group molecules
- o Identify suitable reactions for the formation of main group element-based molecules
- o Recognize the value of main group element compounds for practical applications in materials science and catalysis
