### 3. **Grading:**

The University policy on grading and related matters is described in [F.1](#) and [F.2](#) of the online University Calendar. In determining the overall grade in the course the following weights will be used:

Each of the above components will be given a letter grade using the official university grading system. The final grade will be calculated using the grade point equivalents weighted by the percentages given above and then converted to a final letter grade using the official university grade point equivalents.

This course has a registrar scheduled final exam.

Each piece of work (assignments, midterm exam, paper/poster and final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

### 4. **Missed Components Of Term Work:**

In the event that a student misses the midterm or any course work due to illness, supporting documentation, such as a medical note or a statutory declaration will be required (see [Section M.1](#); for more information regarding the use of statutory declaration/medical notes, see [FAQ](#)). Absences must be reported within 48 hrs.

There are no deferred Midterm/Term Test examinations. If a student misses the midterm for other reasons, then analogous documentation will be required. The course coordinator will need to see the original documentation (not electronic copy) for review / decision and keep it (or a copy) for their records. The documentation must be provided to the course coordinator within 15 days of the date of the midterm in order for an excused absence to be considered. If an

excused absence is approved, then the percentage weight of a legitimately missed midterm examination will be pro-rated among the remaining components of the course (see Section E.3).

**Course Outcomes:**

- INTERFACES: Understand the origin of interfacial tension, its thermodynamics, and examples of interfacial tension in chemistry and nature.
- SOLID SURFACES: Understand surface crystallinity and its effect on surface energy. Become familiar with and understand principles of advanced surface characterization methods.
- ADSORPTION ISOTHERMS: Understand driving forces of adsorption, the meaning of different isotherms, and how adsorption is measured, and the connection with surface catalysis.
- DOUBLE LAYERS AT SOLID/LIQUID INTERFACES: Understand origin of double layers and impact on practical electrochemical processes.
