¹ Students will work in a group of 3 - 4 students on a topic that is related to the contents covered in the course. The students will give an oral group presentation on the topic of their choice to the class in the lecture time during the last two weeks of class.

² The assignments will be for individual student to complete. There will be 2-3 assignments. Assignment dates will be announced in-class (and/or posted on D2L) at least 14-days in advance of the due date.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

Course Outcomes:

- INTERFACES: Understand the origin of interfacial tension, its thermodynamics, and examples of interfacial tension in chemistry and nature.
- SOLID SURFACES: Understand surface crystallinity and its effect on surface energy. Become familiar with and understand principles of advanced surface characterization methods.
- ADSORPTION ISOTHERMS: Understand driving forces of adsorption, the meaning of different isotherms, and how adsorption is measured, and the connection with surface catalysis.
- DOUBLE LAYERS AT SOLID/LIQUID INTERFACES: Understand origin of double layers and impact on practical electrochemical processes.
