² Four problem sets are anticipated. Each will be a set of take-home exercises, and students will have at least one week to complete.

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

4. Missed Components Of Term Work:

If a student has missed a quiz for legitimate reasons, the weights of the remaining quizzes may be adjusted at the discretion of the instructor. If students miss more than 2 quizzes, the corresponding weight of the additional missed quiz(zes) will transfer to the final exam.

If an absence is not approved, the contribution of that specific component item in the final course grade will be zero.
