2. **Requisites:**

See section [3.5.C](#) in the Faculty of Science section of the online Calendar.

Prerequisites: Enrollment in a graduate program in the Department of Chemistry or consent of the Department. It is **recommended** that students have successfully completed 3 undergraduate courses in organic chemistry. Students concerned about their level of preparation should contact the course coordinator for guidance.

3. **Grading:**

Each piece of work (reports, assignments, quizzes, midterm exam(s) or final examination) submitted by the student will be assigned a grade. The student's grade for each component listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade.

The conversion between a percentage grade and letter grade is as follows.

The percentage cut-offs shown above may be decreased based on the overall performance of the class and the difficulty of the exams. The percentage cut-offs will not be increased regardless of class performance.

This course has a registrar scheduled final exam.

4. Missed Components of Term Work:

Deferred examinations will only be provided for the Final Examination and then only with the approval of the Associate Dean. There are no deferred midterms.

Absences from midterm examinations must be reported within 48 hours. In the event of illness, an official medical note is required. Absences for other reasons will require analogous documentation. The course coordinator will need to see the original documentation for review, and must keep the original or a copy for their records. Documentation must be provided within fifteen days of the missed midterm for review. If the absence is approved after review, the weight of the missed examination will be transferred evenly to the other course components.

The recommended textbook is not required for the course, but does provide useful complementary readings. It is recommended especially for students who will be focusing on organic chemistry for their degree program.
