2. **Prerequisites:** consent of the Department

Written Report (approx. 40 pages; due by Apr. 8) 65% (Content 40%, Organization 25%)  
Oral Presentation 35% (To be scheduled by the instructor)

A passing grade (70% or more) on the oral presentation is required in order to pass the course.

Each piece of work (written report and oral presentation) submitted by the student will be assigned a percentage score. The student's average percentage score for the various components listed above will be combined with the indicated weights to produce an overall percentage for the course, which will be used to determine the course letter grade. The conversion between course percentage and letter grade is given below:
